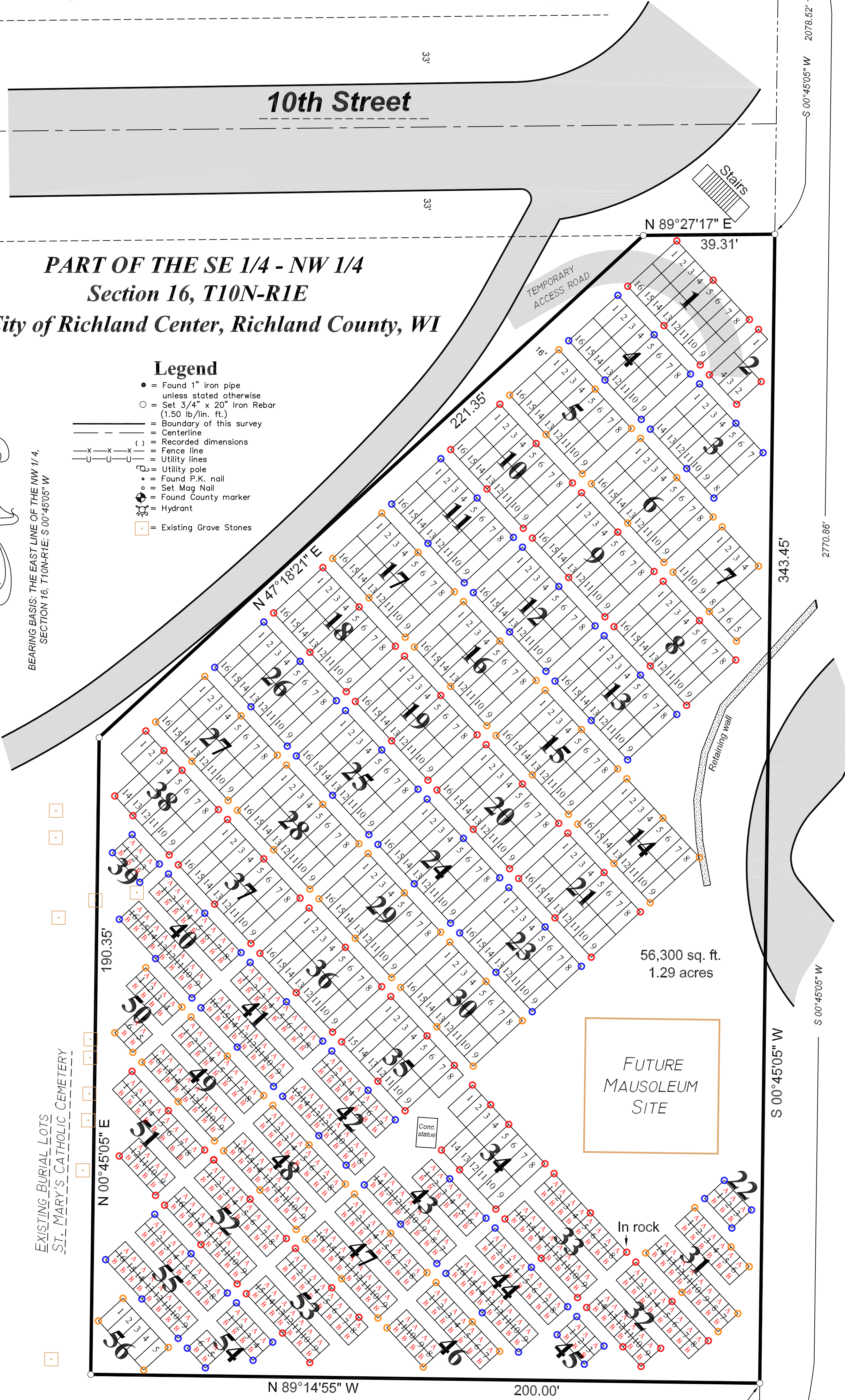

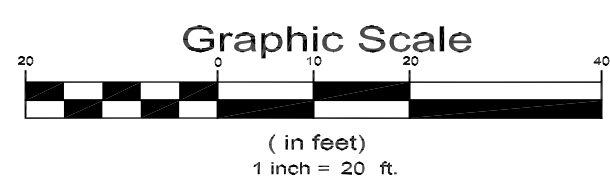
BEARING BASIS: THE EAST LINE OF THE NW 1/4, SECTION 16, T10N-R1E, S 00°45'05" W

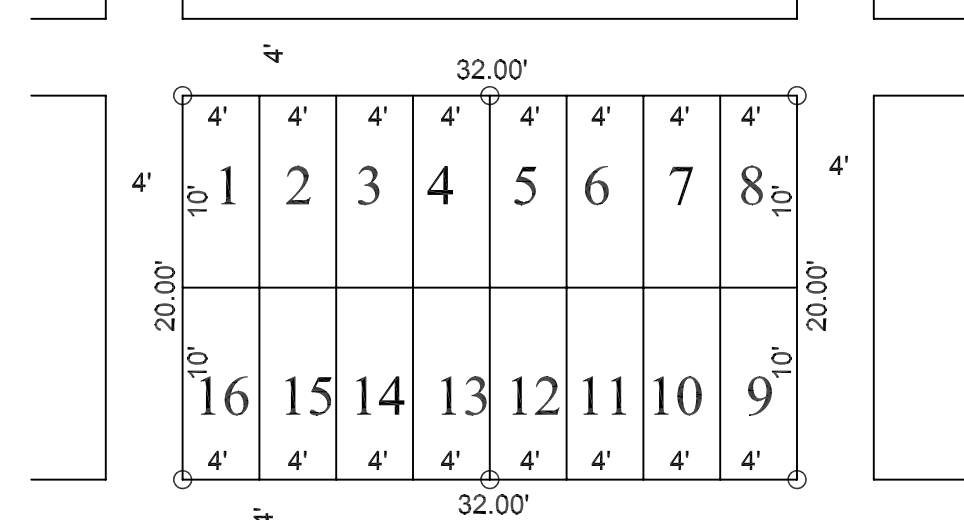

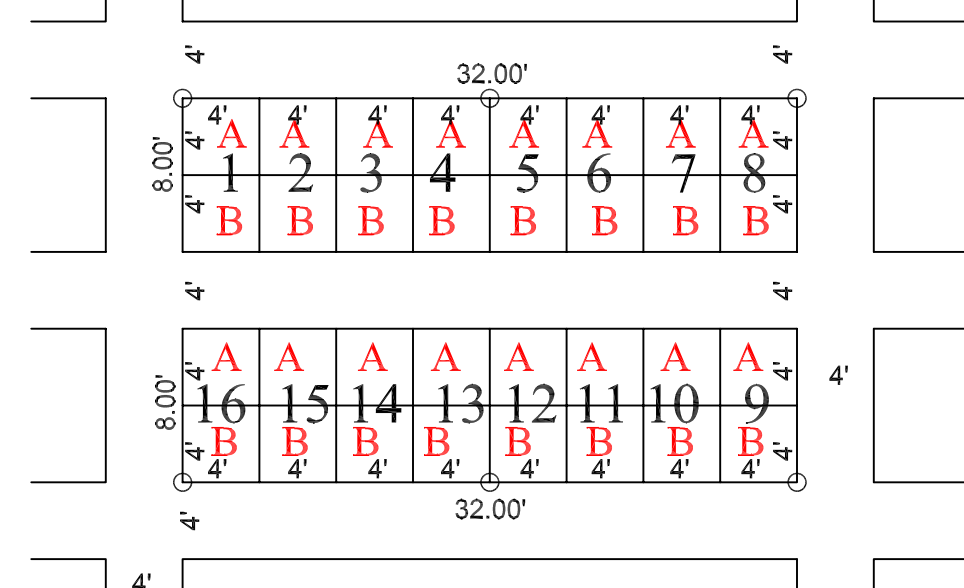
